


A MESSAGE FROM THE BOARD OF EDUCATION PRESIDENT

Dear Patchogue-Medford Community,





In looking back over this past year, I'd like to give special attention to one accomplishment that has tremendous importance for our District: This year, with eight of our schools coming off the New York State Education Department's target list, all 11 of our schools are now officially considered in "good standing" by NYSED! That is a testament to the efforts of our administrators, faculty, staff, students, and our community. With this development, we can now focus on letting the rest of the state know what we in Patchogue-Medford know instinctively: our students, educators, and schools are doing incredible things.

As you review the pages that follow, you will note that we are limiting our tax levy increase to under our allowable tax levy cap. Additionally, you'll notice that there is a second proposition seeking approval from the community to withdraw \$13.5 million from our capital reserve funds to perform a building expansion at Bay Avenue Elementary School. Approval of this proposition will have no impact on property taxes.

The District Budget Vote and Board of Education Trustee Election will be held on Tuesday, May 16, 2023. We invite you to attend the Budget Hearing which will be held on Thursday, May 4, 2023 at 7:00 p.m.



PROPOSITIONS ON THE 2023-2024 BALLOT

PROPOSITION 1: "Shall the Patchogue-Medford School District budget for fiscal year 2023-2024 be adopted and the requisite portion thereof raised by taxation on the taxable property of the District?"

PROPOSITION 2: "Shall the Board of Education of the Patchogue-Medford Union Free School District be authorized to expend no more than eight million five hundred seventy thousand thirty-eight dollars (\$8,570,038.00) from the Capital Reserve Fund – 2018, established on May 15, 2018, and five million dollars (\$5,000,000.00) from the Capital Reserve Fund – 2022, established on May 17, 2022 ("Reserve Funds") plus any accumulated interest pursuant to Section 3651 of the Education Law, for the following capital improvement projects: (1) construction of a building addition at the Bay Avenue Elementary School, including the relocation of a playground area and backstop; (2) site improvement projects at various buildings; all of the foregoing to include site improvements, furnishings, equipment, apparatus, machinery, demolition and other incidental work or improvements required in connection therewith including costs incidental to such improvement, and to expend from the Reserve Funds, and other legally permissible sources therefor, including preliminary costs and costs incidental thereto in an amount not to exceed the estimated total cost of thirteen million nine hundred thousand dollars (\$13,900,000.00)?"

ELECTION OF PATCHOGUE-MEDFORD BOARD OF EDUCATION MEMBERS

The two (2) candidates receiving the highest number of votes will be elected as Members of the Board of Education for a three-year term, commencing July 1, 2023 and ending June 30, 2026. You may vote for a separate write-in candidate for any vacancy.







DISTRICT HIGHLIGHTS

2022-2023 Instructional Highlights

- All schools designated as in need of support and improvement have been moved to good standing with NYSED.
- Implementation of the National Geographic Reach Higher Program and a new strategic writing course at the middle schools.
- Implementation of a 9-period day at the middle and high schools.
- Expansion of Career and Technical Education program at PMHS to include Fashion Design and Merchandising.
- Introduction of new electives at the middle schools to include Wellness, STEM, Crime Scene Investigation, Drone Technology, and Presentation and Debate, plus expansion of the electives program for middle school ACES students.
- Creation of an elementary newcomer program for English Language Learners.
- Expansion of integrated co-teaching classes at PMHS in the areas of math and science.
- Increase opportunities for students with disabilities (SWD) to be integrated (K-12) with non-disabled peers.
- Update of the Social Emotional curriculum, and introduction of a suicide prevention curriculum.

2023-2024 Instructional Initiatives

- Full implementation of a new K-5 literacy program and a pilot K-5 math program.
- Expansion of the Career and Technical Education program at PMHS to include Cosmetology.
- Introduction of new middle school electives, including Career and Financial Management and Understanding Natural Disasters.
- Introduction of new ACES program at Tremont Elementary School.
- Expansion of the Unified Sports program to include cheerleading.





2022-2023 Technology Highlights

- Digital signage upgrade at PMHS and planned digital signage installation at all elementary schools.
- Finalize deployment of ParentSquare Districtwide.
- Implementation of Lightspeed Alert to protect students and alert administrators when intervention is needed.
- Installation of Zoom rooms at five buildings to assist with remote Committee on Special Education (CSE) meetings.
- Cybersecurity enhancements, including internal assessment, internal penetration testing, planned installation of multi-factor authentication, and review of network permissions and access.

2022-2023 Facilities Highlights

- Installation of new floor tile in three science rooms at Saxton Middle School.
- Improvements in the gymnasium at South Ocean Middle School including installation of a new gym floor and creation of a new fitness center.
- Completion of the tennis court refurbishment at Oregon Middle School.
- Renovation of courtyard at Medford Elementary School to create an outside learning space.
- Installed new fencing and safety gate at River Elementary.







BALLOT & VOTE INFORMATION

VOTER QUALIFICATIONS:

To be eligible to vote in school district elections, a person must:

- Be at least 18 years of age
- Be a resident of the school district for at least 30 days prior to May 16, 2023
- Be a citizen of the United States
- Be a registered voter with the Board of Registry or with the Suffolk County Board of Elections

- District No. 1: South Ocean Middle School
- District No. 2: Medford Elementary School
- District No. 3: Saxton Middle School
- District No. 4: Tremont Elementary School
- District No. 5: Eagle Elementary School

VOTER REGISTRATION:

Any school day at the Administrative Center, 241 South Ocean Avenue, Patchogue, New York, 9 a.m. to 4 p.m. Contact the District Clerk (631-687-6370) for further information. The deadline to register with the School District Board of Registry is Monday, May 8, 2023 by 4 p.m.

ABSENTEE BALLOTS:

Absentee ballot applications may be obtained at the Administrative Center, 241 South Ocean Avenue, Patchogue or via the District website (www.pmschools.org). Ballots will be issued upon the satisfactory completion of the application form. Absentee Ballot Applications may not be filed prior to April 17, 2023. The deadline for filing absentee ballot applications, if the ballots are mailed to the resident, is May 9, 2023 by 4:30 p.m. The deadline for filing absentee ballot applications, if the ballots are to be personally delivered to residents or their authorized representative, is May 15, 2023 by 4:30 p.m. All absentee ballots must be filed with the District Clerk by 5 p.m. on Tuesday, May 16, 2023. Information regarding Military Ballots may be obtained by contacting the District Clerk.
