What is the CRRSA Act?

- Federal emergency funds that were given to a State or Local Educational Agency in response to the COVID-19 pandemic.
- Can be used for a wide range of activates to address the needs of individual school districts arising from or exacerbated by the COVID-19 pandemic:
 - Responding to students' social, emotional, and mental health needs (SEL).
 - Academic needs.
 - Health and safety.
 - Funding additional staff.
 - Allocating resources that advance equity initiatives and ensures that adequate supports are provided to students based on the disproportionate impact of the COVID-19 pandemic on at-risk subgroups.


What is the American Rescue Plan (ARP) Act?

- Federal emergency funds that were given to a State or Local Educational Agency in response to the COVID-19 pandemic
- Requires that districts spend at least 20% on learning loss
 - Summer learning/enrichment.
 - Extended Day Programs throughout the school year.
- The balance can be used on the same items as CARES Act Grant:
 - Purchasing of supplies to sanitize/clean buildings.
 - Repair and improve school facilities to reduce the risk of COVID transmission.
 - Improve indoor air quality.
 - Address the needs of Students with Disabilities (SWD's), low-income families, English Language Learners (ELL's), and racial/ethnic minority students.
 - Purchasing educational technology.
 - Providing mental health services and supports.
 - Other activities that are necessary to maintain the operations and continuity of services.

Instructional Programs




- Full Day Pre-K option for families (limited seats).

- Additional Teachers of English to Speakers of Other Languages (TESOL) to support entering and emerging English Language Learners (ELLs).

- Full Remote Teachers (if required).
- · iReady Professional Development and additional resources for AIS program.
- · Additional permanent substitute teachers.
- Expansion of the Technology Department to support1:1 device initiative
 - Technology Integration Specialist
 - Network System Specialist
 - · Network System Technician
 - Computer Aide
- Summer Supports for high school students in need of credit recovery to stay on-track for graduation.
- Summer Supports for students in grades K-8.
 - For at-risk students who have experienced learning lose due to COVID-19 pandemic.
 - Students invited based on academic need.
 - Transportation will be provided for families in need.
 - Focus on Literacy and Mathematics.
