



#### PROPOSITION 1 — SCHOOL DISTRICT BUDGET

"Shall the Patchogue-Medford School District Budget for fiscal year 2021-2022 be adopted and the requisite portion thereof raised by taxation on the taxable property of the District?"

#### PROPOSITION 2— AUTHORIZATION TO REALLOCATE FUNDS

"Shall the Board of Education of the Patchogue-Medford Union Free School District be authorized to reallocate \$1,100,000 of unexpended funds previously approved for the purpose of purchasing portable classrooms at Bay Elementary School from the 2019-2020 school year budget to be used for the purpose of Univent replacements at South Ocean Middle School and/or Career and Technical Education modifications at Patchogue-Medford High School and costs incidental thereto without incurring any additional charge to the taxpayer in the 2021-2022 school year?"

#### **ELECTION OF PATCHOGUE-MEDFORD BOARD OF EDUCATION MEMBERS**



- \* Implement new mathematics Academic Intervention Services (AIS) for all elementary schools;
- Introduce new ACES curriculum, including enhanced Work-Study Programming;
- Expand the CTE program at the High School to include childhood development and education class;
- \* Implement Restorative Practices in grades K-5.



#### **CAPITAL & TECHNOLOGY IMPROVEMENTS SCHEDULED FOR 2021-2022**

- Completion of the 1:1 electronic device initiative by deploying laptops to all remaining students in grades K-4;
- Provision of new laptop devices to all remaining full-time teachers;
- Replacement of the Univent system at South Ocean Middle School;
- Installation of additional wireless access points inside and outside of school buildings districtwide;
- \* Renovation of classrooms at the High School for additional CTE programs;
- \* Upgrade of districtwide security software, hardware, and building access;
- \* Replacement of Storage Area Network and host servers;
- Installation of additional interactive displays.













#### **QUESTIONS AND ANSWERS**

#### DID THE DISTRICT RECEIVE AN INCREASE IN STATE AID?

Yes, the recently enacted State budget included an increase of \$4,397,177 for the 2021-2022 school year.

#### DID THE DISTRICT RECEIVE ADDITONAL FINANCIAL SUPPORT FROM THE FEDERAL GOVERNMENT?

Yes, the District received approximately \$7.4 million from the Coronavirus Response and Relief Supplemental Appropriations Act and another \$16.1 million from the American Rescue Plan Act which can be utilized through September 2024. This support will be made available to the District through Federal grants and its permissible use will be determined by the State and Federal governments.

#### WHAT NOTABLE STAFFING CHANGES ARE INCLUDED IN THE PROPOSED BUDGET?

The 2021-2022 proposed budget includes the increase of a Dean at each of the three middle schools. The District is also proposing the hiring of a Mental Health Coordinator in the Family Center, five new Teaching Assistants in our Special Education Department, an Instructional Technology Support Consultant, as well as six new teachers to provide Academic Intervention Services (AIS) in Mathematics.

#### ARE THERE ANY STAFF REDUCTIONS INCLUDED IN THE PROPOSED BUDGET?

There are no proposed staff reductions for the 2021-2022 school year.

#### ARE THERE ANY ADDITIONAL PROPOSITIONS TO BE PRESENTED FOR VOTER APPROVAL?

Yes, there will be an additional proposition on the ballot for the reallocation of \$1,100,000 of unexpended funds from an interfund transfer to capital. The funds were previously approved for the purpose of purchasing portable classrooms at Bay Elementary School from the 2019-2020 school year budget and now intend to be used for the purpose of Univent replacements at South Ocean Middle School. Should there be remaining funds available, the District will use them for Career and Technical Education modifications at Patchogue-Medford High School. The taxpayers will not incur any additional charges in the 2021-2022 school year as a result of this proposed reallocation.

#### ARE THERE ANY SPECIAL INITIATIVES PROPOSED FOR THE 2021-2022 SCHOOL YEAR?

The District intends to complete its 1:1 electronic device deployment initiative by providing laptops for all students in kindergarten through grade four. This will complete the District's efforts, which began just last year, to deploy laptops to all students in grades kindergarten through twelve.

#### HOW DOES THE TAX CAP IMPACT THE TAX RATE?

The 2% tax cap (with exclusions) implemented by the Governor and the Legislators does not cap the tax rate, it caps the tax levy. The levy is one component to calculating the tax rate. The assessed valuation is the other component used to calculate the tax rate. The legislation only addressed one component of the calculation (the levy). Depending on whether assessed valuation remains the same or declines, the estimated tax rate increase could range from 2.66% to 4.75%. The assessed valuation is determined by the Town and is provided to school districts in the Fall.

#### DOES THE PROPOSED BUDGET PIERCE THE PROPERTY TAX CAP?

The proposed Budget does not pierce the property tax cap.

#### WHAT HAPPENS IF THE PROPOSED BUDGET IS NOT APPROVED?

If the budget fails on May 18, 2021, the Board may either recommend a re-vote on June 15, 2021 or will adopt a contingency budget. If the Board chooses to adopt a contingency budget, it will require approximately \$2,969,923 of additional cuts. All equipment purchases would be eliminated from the General Fund budget as well as the Interfund Transfers to the Capital and School Lunch Funds. The cuts would also require the District to eliminate the proposed Mental Health Coordinator in the Family Center, the Instructional Technology Support Consultant, the new Math AIS positions, and the District would reduce an additional four teachers included in the current proposed budget.

#### **BALLOT & VOTE INFORMATION**

#### **VOTER QUALIFICATIONS:**

To be eligible to vote in school district elections, a person must:

- ♦ Be at least 18 years of age;
- ♦ Be a resident of the school district for at least 30 days prior to May 18, 2021;
- ♦ Be a citizen of the United States, and;
- ♦ Be a registered voter with the Board of Registry or with the Suffolk County Board of Elections.

- ♦ District No. 2: Medford Elementary School
- ♦ District No. 3: Saxton Middle School

#### **ABSENTEE BALLOTS:**

Absentee ballot applications may be obtained at the Administrative Center, 241 South Ocean Avenue, Patchogue or via the District web site (<a href="www.pmschools.org">www.pmschools.org</a>). Ballots will be issued upon the satisfactory completion of the application form. Absentee Ballot Applications may not be filed prior to April 19, 2021. The deadline for filing absentee ballot applications, if the ballots are mailed to the resident, is May 11, 2021 by 4:30 p.m. The deadline for filing absentee ballot applications, if the ballots are to be personally delivered to residents or their authorized representative, is May 17, 2021 by 4:30 p.m. All absentee ballots must be filed with the District Clerk by 5 p.m. on Tuesday, May 18, 2021. Information regarding Military Ballots may be obtained by contacting the District Clerk.
