


## GRADE LEVEL OF RESPONDENTS CHILD(REN)



# CURRENT FULL REMOTE ENROLLMENT










## WHAT MODEL DO YOU PREFER FOR K-2 STUDENT?






## WHAT MODEL DO YOU PREFER FOR 3-5 STUDENT?





## WOULD YOU UTILIZE SCHOOL TRANSPORTATION IF STUDENTS RETURNED 5-DAYS PER WEEK?


















# WOULD YOU PREFER PDP/EXTRA-HELP RETURN TO BEFORE THE INSTRUCTIONAL DAY?





# ARE STUDENTS LOGGING INTO TEAMS TO PARTICIPATE IN LIVE INSTRUCTION ON WEDNESDAY?









## RECOMMENDATIONS FOR PHASE 2-HIGH SCHOOL

Students in the HS will following a 9-period schedule when in-person and we will continue the Live Steaming for CTE and World Languages

Students in the HS will have a Full Remote Day on Wednesday.

Students will be required to videoconference (Live Stream) for each of their scheduled periods (excluding study halls)

Teachers will receive professional development on webcams in preparation of Live Streaming

The district will continue to deploy 1-1 devices at the high school. We anticipate completing by early December

The district will continue to update bandwidth at the high school

Live Streaming will begin for all classes at the high in January

## RECOMMENDATIONS FOR PHASE 2-MIDDLE SCHOOLS

Students in the MS follow an 8period schedule when in-person

Schedules will need to be adjusted and some teacher assignments may change.

All specials will now take place in-person

Students in the MS will have a Full Remote Day on Wednesday.

Students will be required to videoconference (Live Stream) for each of their scheduled periods.

Teachers will receive a professional development day to prepare for full implementation of Live Streaming.

Students will begin to follow an 8-period day the beginning of Quarter 2 All students on Full Remote will return to their home school and follow an 8-period day. Teacher assignments will be adjusted accordingly. Students will remain on Full Remote and be required to Live Stream each day.

Live Streaming will begin for all classes on November 23.

Students must login to all their classes when home remotely.

## RECOMMENDATIONS FOR PHASE 2-ELEMENTARY SCHOOLS

Adjustments to the Wednesday schedule will be made to increase videoconferencing time with classroom teachers.

Students in grades 3-5 will report to school 4-days per week

- Full Remote students will not login for Live Instruction.

- All registration applications MUST be received no later than 5:00 pm on Friday, November 13.
